

NAIDOC in the City - Marketplace Stallholder Expression of Interest Monday 8th July, 2013

BACKGROUND INFORMATION

The City of Sydney will once again be hosting the NAIDOC in the City celebrations held on July 8 in Hyde Park North. There will be performances by Australia's top Indigenous entertainers, traditional dancing, Yidaki (didgeridoo) playing workshops, great food and more.

STALLHOLDERS WE ARE LOOKING FOR

The NAIDOC in the City Marketplace aims to showcase those individuals and small businesses from Indigenous and Torres Strait Islander cultures who trade in traditional and contemporary arts and crafts, retail products or small goods.

STALL REQUIREMENTS / INFORMATION

The decision of Stallholders to be included in the NAIDOC in the City Marketplace remains at the sole discretion of City of Sydney and Vibe Australia. A completed registration does not guarantee inclusion into the event.

All stallholders are required to supply current copies of insurance cover.

Equipment, including tables, chairs and all products must be kept within your site boundaries.

No sound systems or broadcasting is allowed from individual sites, and no items can be pegged into the ground eg. Signs with stakes

The sale of alcohol, tobacco or tobacco products, illegal goods, weapons or illicit substances is prohibited.

The NAIDOC event in Hyde Park prefers no plastic bags be used, and we require packaging to be recyclable where possible.

Please note that we cannot guarantee exclusivity.

Any decisions made by City of Sydney or Vibe Australia are final and no correspondence will be entered into.

SETUP / EVENT / PACK UP TIMES

PLEASE NOTE: TIMES ARE INDICATIVE AND CAN BE CHANGED PRIOR TO THE EVENT. DEPENDING ON THE NUMBER OF APPLICATIONS WE RECEIVE, SOME STALLHOLDERS MAY BE REQUIRED TO BUMP IN ON SUNDAY THE 7th OF JULY, 2013.

ACCESS AND PARKING

Stallholders will be issued with a pass, which will allow vehicle access for set up and pack down. Please note you must remove your car immediately once all items have been dropped off. No parking has been allocated on site.



ALLOCATION OF SITES

The allocation of sites is at the discretion of The Organisers. In allocating sites, the Organisers:

- Allocate participants a particular site and all sales and equipment must remain within this site.
- Cannot and does not guarantee attendances or profit levels at the event. Any loss of profit or custom incurred is to be borne by the participant and no correspondence will be entered into.
- Will not be liable for the refund of any site fees if an event does not proceed for any or all of the hours programmed because of inclement weather, partial or complete failure of electricity supply, or any other factor beyond the control of event organisers.

- 1. We reserve the right to accept or refuse any stallholder application at our sole discretion.
- 2. Incomplete applications, or applications submitted without proof of current Public Liability Insurance will not be considered.
- 3. You acknowledge that you agree to the stallholder Cancellation Policy as outlined on page 1 of this document.
- 4. Stall sites will be allocated on a first come first served basis. You will be notified of your site allocation 7 days prior to the event. Allocations are final and no changes will be permitted without the express written consent of the Event Organiser
- 5. We reserve the right to reallocate sites at any time to accommodate sponsors or existing businesses within the event footprint.
- 6. You may only trade within the event operating hours, specified on page 1 of this document.
- 7. You are only permitted to sell items outlined in this application. If you are found to be selling items that in our opinion differ significantly from what was outlined in your application you may be closed down and ejected from the event.
- 8. The following items are prohibited for sale at the event: illegal goods, weapons, illicit substances, tobacco and tobacco products, live animals, alcohol, any goods which are fake or illegal copies of designer goods. If you are found to be selling a prohibited item you will be closed down and ejected from the event
- 9. All electrical goods used must have current test and tag labels showing. All electrical equipment will be checked by the event organiser prior to the commencement of trading, and any non compliant equipment will not be permitted to be used during the event. If you draw more power than is allocated in this application or if the on-site electrician is asked or required to attend your electrical equipment because of fault or repair, you will be charged accordingly.
- 10. You acknowledge that the event is an all weather festival. We will make no refunds or compensation of any kind in the instance of alleged reduced sales due to inclement weather.
- 11. To the fullest extent permitted by law, we do not accept liability of any nature for the acts, omissions or default of those providing services, in connection with the event, or any liability for any injury, damage, loss, delay or additional expenses which are incurred at or in association with the event. Where legislation implies any condition or warranty, which cannot be excluded or modified, that condition or warranty will be deemed to be included in this agreement. However, to the fullest extent permitted by law, our liability for breach of any implied warranty, condition or undertaking which cannot be excluded is limited. - 15. You will be liable for any loss or damage caused at the event by you or your employees.
